

## Changes to FY 2012-2013 FDP Prevailing Rates that will be in effect for FY 2013-2014

### Region 1

A80 - **Site Prep, chemical, control, ground...**all 4 districts...from 45/90/130 to 80/100/130 (changes made to low & medium rates)

C10 – **Hand plant, loblolly** from 65/70/80 to 65/75/85...D-4, D-7, D-13

C10 – **Hand plant, loblolly** from 65/75/80 to 65/75/85...D-8

**Hand Plant, containerized pine** changed from loblolly rate & longleaf rate to low (\$115) and high (\$135) for all species...all 4 districts

Codes: C13 **longleaf, containerized pine** (60%)

C15 **shortleaf, containerized pine** (60%)

C19 **loblolly, containerized pine** (40%)

**Machine Plant Pine...**all 4 districts... took off loblolly & longleaf rates **Shortleaf** added (C25) rates changed to 70(L)/90(M)/135(H)

**Machine Plant, Chemical, Pine...**all 4 districts... **shortleaf** added (C26); added \$5 to Machine Plant rates to 75(L)/95(M)/140(H).

### Region 2

A40 – **KG, V-Blade Shear** changed to \$160 for all 5 districts

C11 - **Hand plant, hardwood** changed high rate from \$170 to \$190 for all 5 districts

C10 – **Hand plant, loblolly** changed from \$75 to \$80...D-5, D6 & D-11

C10 – **Hand plant, loblolly** changed from \$80 to \$85...D-3 & D-10

**Hand Plant, containerized pine** changed from loblolly rate & longleaf rate to low (\$115) and high (\$135) for all species...D-5, D-6, D10, D11

**Hand Plant, containerized pine** changed from loblolly rate & longleaf rate to low (\$115) and high (\$140) for all species...D-3

Codes: C13 **longleaf, containerized pine** (60%)

C15 **shortleaf, containerized pine** (60%)

C19 **loblolly, containerized pine** (40%)

**Machine Plant Pine...**all 5 districts... took off loblolly & longleaf rates and added a mid rate (\$90)to now have a low/mid/high for all species; **shortleaf** added (C25)

75/90/130 D-3; 70/90/125 D-5; 75/90/125 D-6 ; 75/90/115 D-10; 80/90/125 D-11

**Machine Plant, Chemical, Pine...**all 5 districts... rates stay the same; **shortleaf** added (C26)

### Region 3

Added **Hand Plant, containerized pine** with a low rate \$125 and a high rate \$150 for all 4 districts

Codes: C13 **longleaf, containerized pine** (60%)

C15 **shortleaf, containerized pine** (60%)

C19 **loblolly, containerized pine** (40%)

**Machine Plant Pine...**all 4 districts... rates stay the same; **shortleaf** added (C25)

**Machine Plant, Chemical, Pine...**all 4 districts... rates stay the same; **shortleaf** added (C26)
